If the paper is accepted, it will be published in the June 2017 issue. By the final submission for publications, the authors assign all the copyrights to the Tanzania Public Service College. The Editorial Board reserves the right to change/alter the final submissions for TPSC for editorial purposes.

Articles, papers or cases submitted for publication should be original contributions and should not be under consideration for any other

publication at the same time.
